How it Works

- If school staff determine your child requires care beyond their ability, they will contact you and ask if you would like your child to be evaluated and treated at St. Luke's Children's School-Based Health Clinic.
- Clinic staff will evaluate your child and communicate with you about recommended treatment. Staff will obtain verbal consent before giving your child any medical treatment.
- Staff will provide you with any additional information regarding the appointment.
- Staff will recommend whether your child can safely return to school, should go home, or requires additional treatment.
- It's your responsibility to coordinate with the school as to whether your child will be allowed to remain onsite or need to be taken home.

Confidentiality

Your child's visit will be documented as part of their medical record, and subject to legal privacy protections. You may be asked to complete a HIPAA (Health Insurance Portability and Accountability Act) authorization that allows St. Luke's to share information about your child's medical treatment with appropriate staff at the school.

Costs and Billing

Services provided at St. Luke's Children's School-Based Health Clinic will be billed to your insurance. Insurance information will be collected with other registration forms and may be verified by St. Luke's staff before your child's appointment. School-Based Health Clinic



St. Luke's Children's School-Based Health Clinics are located on site at Central and Snake River Elementary schools.

At the School-Based Health Clinic, students can be evaluated and treated with minimal interruption to their school day or their parent's work day. Staffed by a pediatrician or nurse practitioner and medical assistant, the clinic is open to children who are students at Snake River or Central Elementary schools. Ask the school staff to learn more about the School-Based Health Clinic schedule.

Our Services

We treat children who have minor illnesses and injuries such as:

- Strep throat
- Influenza (flu)
- Infectious mononucleosis (mono)
- Respiratory syncytial virus (RSV)
- Urinary infections
- Mild concussions
- Scrapes, strains, bruises

We also offer wellness exams.



The clinic does not treat children with emergency symptoms such as severe bleeding, compound fractures, seizures or severe allergic reactions. In an emergency, St. Luke's staff will immediately involve appropriate emergency medical personnel.

Parent Permission for Care

- As a child's parent or legal guardian, you must complete forms ahead of time that allow your child to be seen at the clinic. If you wish, you can designate that your child can be examined and treated without you being present.
- Please return these forms to the School-Based Health Clinic.
- All forms must be completed and turned in before your child can be seen at the clinic.

- Along with the completed forms, your verbal consent will also be required before your child can be seen at the clinic.
- If your child becomes sick or injured, clinic staff will be able to evaluate their symptoms, diagnose the medical condition, and prescribe appropriate medications, if necessary.
- Clinic staff will coordinate with you, via phone conversation, about proposed treatment for your child and obtain verbal consent from you before any treatment is given.
- You are always welcome to be present with your child at the clinic.

When a Parent Must be Present

If your child's medical situation requires a more in-depth evaluation or treatment, staff will ask that you come to the clinic for your child's care appointment. If you're unable to attend the appointment, clinic staff may be unable to provide recommended medical treatment to your child.
